How to register to play Soccer/Futsal at LifeQuest Fitness Center

1. All Non-members must purchase a Player's card each season. **Player's card fee: \$10.00.** The season will begin and end yearly in September. To purchase a Player's card, please provide photo identification, current address, telephone or mobile phone, email and date of birth information to be kept on file. **Youth division players are exempt from purchasing a players card. Youth players are required to provide date of birth documentation.**
2. **Player's registration fee: \$35.00.** Each individual payer on a team must pay his/her own registration fee, the registration fee will be due for each session or league the player wishes to participate in. Each player may only register for one team per division during each session.
3. Parental/Guardian liability waivers must be filled out for all players under the age of 18.
4. Game spectators over the age of 18 will be charged \$1.50 per game or may purchase a seasonal (yearly) Player's Card. Youth division spectators (parents/grandparents/siblings) will be exempt from spectator fees.
5. **Total due: \$45.00 includes tax - Total Due: \$35.00 includes tax**
